Tulsa Area Prime Timers Monthly Meeting April 2 2010

Meeting called to order by President Steven D. at 7pm.

Secretary report was read by John M. Motion to adopt the report as read by Norman H. and second by Owen T. The motion was passed by the members present.

Treasury's report was read by Murrel W. Motion to adopt the report as read by Owen T. and second by Havah G. The motion was passed by the members present.

Activities report was presented by John M.

Old Business- TAPT web site was revisited by Steven D. reporting the site is up and running. He explained each page on the site.

Pride 2010 was revisited. Need for volunteers. Contact Owen T. for time. Club will have to supply a table and chairs to man the booth.

Norman H. was thanked for hosting the movie night in March. Members attending wished the activity continued. Members were asked on types and names of movies and new venues.

Revisited TAPT By-laws. Change to Article III Section #7 was requested at the March 2010 membership meeting.

New Business-- TAPT By-Laws discussed the change to Article III Section #7. The board of Directors voted to change the wording of Section #7 from :The term of office for all officers shall be **one** year. Officers may only serve on the Board of Directors for a maximum of two consecutive terms in each office; the Treasurer may be re-elected for more than two (2) consecutive terms. Vacancies in offices shall be filled by a special election at a regular business meeting of Tulsa Area Prime Timers determined by the Board of Directors, no later than sixty (60) days after the vacancy occurs. The special election shall be announced at least fourteen (14) days prior to the meeting at which the election will be conducted. The Nominating Committee shall submit nominations for vacancies and nominations from the floor shall be accepted.

The new adopted wording of Section #7 to: The term of office for all officers shall be **two** year. Officers may only serve on the Board of Directors for a maximum of two consecutive terms in each office; the Treasurer may be re-elected for more than two (2) consecutive terms. Vacancies in offices shall be filled by a special election at a regular business meeting of Tulsa Area Prime Timers determined by the Board of Directors, no later than sixty (60) days after the vacancy occurs. The special election shall be announced at least fourteen (14) days prior to the meeting at which the election will be conducted. The Nominating Committee shall submit nominations for vacancies and nominations from the floor shall be accepted.
